About the report

Municipality of Braga was prepared as a voluntary response aligned with the latest Global Reporting Initiative Standards under the "Comprehensive" option. It aims to address the requirements for disclosing sustainability and quality of life indicators. For the greenhouse gas emissions inventory, the report was prepared in accordance with the guidelines of the Greenhouse Gas Protocol (GHG Protocol). The GHG Protocol Corporate Accounting and Reporting Standard was applied to the Municipality of Braga's operational emissions, while the Global Protocol for Community-Scale Greenhouse Gas Emission Inventories was applied to community emissions. Both inventories align with those submitted for the annual reporting to the Carbon Disclosure Proiect for Cities.

This is the second sustainability report from the Municipality of Braga, aiming for an annual publication cycle. As part of this process, a new materiality analysis was initiated, based on extensive consultations with stakeholders and the general community within the municipality.

The outcomes of this process have been considered in defining material topics, which are also essential in building the Municipality of Braga's Sustainable Development Strategy. This report highlights the Municipality's performance across various material topics, providing context and alignment with national, European, and international sustainability agendas, particularly the United Nations Sustainable Development Goals. The report seeks to demonstrate a comprehensive and strategic view of the Municipality of Braga's activities and how the organization is contributing to key sustainability issues.

Report Period, Scope, and Boundaries

This Report pertains to activities carried out during the period from 2020 to 2023 (January 1, 2020, to December 31, 2023), based on data availability at the time of collection. Consequently, due to the absence of updated information, some indicators may reflect data up to 2021/2022.

The boundaries of the information reported are, in a preliminary analysis, confined to the operational activities and impact of the Municipality of Braga as a public organization. In a secondary analysis, they extend to the Braga municipality itself, through territorial administration by elected representative bodies, as well as its role as a local authority.

Reported Information and Review

The verified information in the Report is limited exclusively to financial topics, with

this verification following the Financial Statements and Accounts. Since this is a voluntary report, the remaining information was reviewed in advance by various bodies within the Municipality of Braga, as well as public and private organizations, regulatory entities, and statistical institutions.

Looking to the future, we are excited about implementing our Strategic Plan for Sustainable Development, which includes 10 transformative measures for the Municipality. These measures will not only enhance our internal management but also transform Braga into a more resilient, green, and innovative city. Braga has achieved remarkable overall performance regarding the SDGs. In 2023, the city reached a completion index of 68.8%, demonstrating positive evolution over the years. This result reflects the city's commitment to a comprehensive and integrated approach to tackling social. economic. and environmental challenges. Compared to other Portuguese municipalities, Braga stands out positively in terms of SDG completion. While the national average in 2023 was 62.8%, Braga significantly exceeded this figure, reaching 68.8%. Furthermore, when compared to municipalities in the Cávado region, which had an average of 64.4%, Braga also positions itself above the regional average.

Braga has recorded remarkable progress in various SDGs, particularly in SDGs 3, 4, 6, 9, 10, 12, 15, and 16. In these areas, the city has exceeded expectations, achieving completion rates well above the national average and demonstrating a firm commitment to promoting health, education, access to clean water, innovation, equal opportunities, waste management, nature conservation, and social and institutional justice. These results reflect the positive impact of the policies and initiatives implemented by Braga, as well as the community's engagement in the pursuit of sustainable and inclusive development.

Regarding SDG 3 - Health and Well-being, Braga has been exemplary. With a score of 87.8%, the city demonstrates a strong

commitment to promoting the health of its citizens. Initiatives such as vaccination campaigns, improved access to healthcare services, and promotion of healthy lifestyles have been effective in improving health indicators for the population.

In the realm of education, Braga excels in SDG 4 - Quality Education, with an impressive score of 88.1%. The city has invested in schools and teacher training, ensuring equitable access to quality education for all its residents.

Braga has also achieved an excellent score in SDG 6 - Clean Water and Sanitation (91.1%), highlighting widespread access to drinking water and sanitation services. Investments in infrastructure and water conservation programs have ensured the availability and sustainable management of water resources in the city.

The same is true for SDG 7 - Affordable and Clean Energy (85.2%), where Braga is close to achieving the goal of clean and accessible energy, demonstrating a commitment to renewable energy sources and energy efficiency. Projects for solar panel installation and incentives for public transport have contributed to reducing dependence on fossil fuels and promoting energy sustainability.

Despite the overall progress, Braga faces challenges in some SDGs, particularly SDG 8, SDG 11, and SDG 13. The impact of the COVID-19 pandemic was significant in these areas, breaking a completion dynamic observed over the years and heavily impacting SDG 8. In other areas, the city has seen less significant progress, facing obstacles such as the burden of housing relative to per capita income and overall greenhouse gas emissions, largely due to urban mobility and strong car dependency.

SDG 11 - Sustainable Cities and Communities presents a significant challenge for Braga, with a score of only 38.5%. Despite efforts to promote sustainable urban development, the city still faces issues such as congestion and excessive waste production by its residents. Ongoing investments in efficient public transport projects and sustainable urban planning are being implemented to address these issues.

Meanwhile, SDG 14 - Life Below Water presents a significant challenge for Braga, with a score of only 41.0%. As Braga has no maritime borders, the implementation of this SDG becomes more challenging. The conservation of aquatic ecosystems has been a focus, addressing issues such as river pollution and the degradation of river habitats that have occurred in the past. Projects for river cleanup and environmental awareness have been necessary to reverse this trend.



Performance

In the context of decent work and economic growth (SDG 8), with a score of only 55.7%, the impact of the COVID-19 pandemic and its restrictions has been felt. Despite this impact, particularly in the tourism sector, there has been a strong push for local entrepreneurship, a reduction in unemployment, and various opportunities for decent work.

However, Braga has demonstrated a continuous commitment to overcoming these challenges by implementing comprehensive strategies and involving the community in seeking effective solutions.

Since 2019, Braga has maintained consistent efforts to improve its indicators for each of the SDGs, implementing strategic policies and initiatives in various areas, from eradicating poverty to promoting gender equality, environmental sustainability, and economic development.

The near completion of 70% shows that Braga is on the right path to achieving the targets set by the 2030 Agenda, contributing to a fairer, more prosperous, and sustainable future for all its inhabitants.

2.1 HISTORY AND IDENTITY

From its Celtic origins to its role as an important religious and cultural center in the Iberian Peninsula, the city preserves and celebrates its historical legacy, reflecting centuries of evolution.

History and Identity

the title of "Portuguese Rome."

Founded by the Celts in 300 B.C., the Castro people were the first to inhabit the territory we now know as Braga. Since then, the diversity of today's city has been shaped by waves of migration and various occupations.

Designated as the administrative center of the Roman Empire in 27 B.C., the territory was elevated to city status by Emperor Augustus in 16 B.C., who named it Bracara Augusta in his own honor. In 411 A.D., following the fall of the Western Roman Empire, Bracara Augusta became the political and intellectual capital of Gallaecia, a kingdom founded by the Suevi, a Germanic people.

The medieval period marked a new chapter in the city's history, with its remarkable cathedral (Sé) being a central feature around which the historic center developed. Even before the founding of Portugal, Braga was donated to the Archbishops, becoming an important religious center in the Iberian Peninsula.

The strong religious presence in the city has been marked over the centuries by an increasing number of churches from different periSDG and architectural styles, alongside a valuable collection of sacred art, earning it The art of representing the City's Coat of Arms began during this time, establishing the elements of Braga's Heraldry:

City Coat of Arms

Our Lady dressed in a purple tunic and cerulean blue mantle, crowned in the ancient style with silver, holding a lily in her hand and cradling the Child Jesus in her left arm. Flanked by two silver towers, decorated in black and accompanied by three ancient Portuguese shields featuring five blue escutcheons arranged in a cross, each escutcheon bearing five silver bezants. A mural crown with five silver towers and a scroll at the bottom bearing the legend "Braga."

Municipal Flag

Blue and white with silver and blue cords and tassels. The pole and spear are gold. The flag, which is rectangular (in proportions 2:3) or square, must feature the municipality's coat of arms at its center.

Baroque architecture in the 18th century left a notable mark on the city, making Braga one of the greatest ex-libris of this style in Portugal. Industrialization brought the railway to the city and provided essential infrastructure, allowing a strong industrial sector to flourish.

In the 1990s, in response to the crisis in traditional industrial sectors, Braga successfully reinvented its economic fabric with the emergence of a technology cluster that paved the way for a new era in the city, catapulting it to a status of innovation and knowledge hub.

Territory

Braga is the third-largest city in Portugal, preceded only by Lisbon and Porto. Located in the north of the country, in the Minho region, the municipality of Braga covers an area of 183.4 km² and is organized into 37 parishes.

Its privileged geostrategic position is reinforced by good accessibility, placing it less than an hour away from Porto and Vigo (Galicia, Spain). In terms of territorial units, the municipality of Braga is part of NUTS I – Mainland, NUTS II – Northern Region, and NUTS III – Cávado. It is bordered to the north by the municipalities of Vila Verde and Amares, to the northeast and east by Póvoa de Lanhoso, to the south and southeast by Guimarães and Vila Nova de Famalicão, and to the west by Barcelos. Along with the cities of Guimarães, Barcelos, and Vila Nova de Famalicão, it forms the Urban Quadrilateral, a network focused on strengthening competitiveness and innovation in the territory shared by the four municipalities.

The relief is characterized by the presence of scattered valley areas across the territory, contrasting with small mountainous formations aligned parallel to the main rivers. The municipality of Braga is bounded to the north by the Cávado River, to the south by the elevations forming the Serra dos Picos (566 m), and to the east by the Serra dos Carvalhos (479 m).

With good road and rail access, Braga is close to the main seaports of the Euroregion – Leixões, Viana do Castelo, and Vigo – and Francisco Sá Carneiro Airport, the main hub of the northwest Iberian Peninsula, is just 30 minutes away by car.

Braga is the primary gateway to the Peneda-Gerês National Park, one of the most emblematic protected areas in the country, recognized as a UNESCO Biosphere Reserve.

Population

With 193,349 inhabitants (2021) and a high population density of approximately 1,000 inhabitants/km², the young population of Braga represents a quarter of its residents. Braga is the second municipality in the Northern region with the highest number of residents under 25 years of age.

Within the city, the parishes and unions of parishes have a density of 1,054.2 inhabitants/km², significantly higher than the municipal average, showing a geographical distribution that is unequal compared to the more peripheral parishes. A global analysis of the age structure of residents shows that 70% are of working age (15 to 64 years).



2.2 GOVERNANCE

With an organizational model focused on efficiency, de-bureaucratization, and proximity to citizens, the Municipality is administered and structured according to the Constitution of the Portuguese Republic, distinguished by the presence of representative bodies that ensure the pursuit of interests specific to the local population.

Constitution

Under the terms of the Constitution of the Portuguese Republic, the democratic organization of the State includes the existence of local authorities, which are territorial collective entities endowed with representative bodies aimed at pursuing the interests of their respective populations (Article 235). Municipalities are the local authorities that aim to promote the interests of the residents within the municipality, through representative bodies elected by them.

The organizational model of the services of the Municipality of Braga aims to contribute to the implementation of the municipality's medium-term vision and strategy with greater efficiency and effectiveness, from a perspective of proximity to citizens, debureaucratization, and efficient allocation of public resources, as well as improving the quantitative and qualitative aspects of the services provided.

The representative bodies of the Municipality of Braga consist of an elected assembly endowed with deliberative powers and an executive body accountable to it, specifically:


_ **Municipal Assembly:** This is the deliberative body of the Municipality of Braga, composed of members directly elected in a number greater than that of the parish council presidents who are part of it. (It is composed of 38 directly elected members and 37 presidents of the Parish Councils, totaling 75 members.)

_ **Municipal Chamber:** This is the executive body of the Municipality of Braga. (It is composed of the President of the Chamber and 10 councilors.)

At the political level, the Municipal Chamber of Braga is governed by a municipal executive currently composed of a collective of eleven elected representatives, led by a president. The executive currently comprises 6 elected representatives (including the president) from the coalition "Juntos por Braga," to whom all portfolios have been assigned, along with 4 from the Socialist Party (PS) and 1 from the CDU-Unitary Democratic Coalition (PCP-PEV).

Regulatory Code: The Regulatory Code of the Municipality of Braga is a document that aggregates the main regulations with external effectiveness for the Municipality. This code brings together the main regulations with effectiveness, excluding municipal territorial management instruments.





Structure

The Municipality of Braga is based on an organizational model that is based on the update of the Organic, Nuclear and Flexible Structure of the Municipality's Services, approved at a meeting of the Municipal Assembly on April 1, 2022, based on a proposal by the Municipal Council approved at a meeting on March 21, 2022, drawn up under Decree-Law No. 305/2009, of October 23. This Decree establishes the legal framework for the organization of the Municipality's services.

The organization, structure and operation of municipal services are guided by the principles of unity and effectiveness of action, bringing services closer to citizens, reducing bureaucracy, rationalizing resources and efficiency in the allocation of public resources, improving the quality and quantity of the service provided and ensuring citizen participation, as well as by other constitutional principles applicable to administrative activity and included in the Code of Administrative Procedure.

The most recent approval of the Organic, Nuclear and Flexible Structure of the Services of the Municipality of Braga was carried out at a session of the Municipal Assembly on October 10, 2020. Thus, the Mayor is responsible for coordinating municipal services and the Mayor, or the Councilor to whom the power of management and direction of human resources has been delegated, is also responsible for assigning or reassigning staff from the respective map.

2.3 TRANSPARENCY

Braga adopts a stance of total transparency in public management, promoting accessibility and clarity of administrative information. Through open and communicative practices, the municipality ensures that citizens are well-informed about decisions and the use of public resources, strengthening trust and community participation in local governance.

Management Instruments

Local authorities are a cornerstone of Portuguese democracy, playing a fundamental role in the development of local communities, the civic education of citizens, and public perceptions of the quality of democracy. The practice of accountability is intrinsically present in the culture of the Municipality of Braga and its reporting system.

Annually, a set of management instruments is made available, presenting the status of project implementation, objectives, targets, and, above all, the organization's activities. We can divide the management process of an organization into two main categories:

Planning: The process that leads to the selection of directions and activities to be developed:

- _ Major Options of the Plan
- Plan and Budget
- Activity Plan
- Sectoral Action Plan

Control: The process that verifies whether the desired results are being achieved:

- _ Management and Accounts Report
- _ Consolidated Management Report
- _ Activities Report
- Sustainability Report

The reporting system of the Municipality of Braga is designed to disseminate information to stakeholders that reflects the organization's results and alignment with its projections. It is also through this reporting system that we can communicate and identify which areas/sectors/activities of the municipality are contributing to the defined outcomes.

Risk Management Plan

The Risk Management Plan of the Braga City Council is established in compliance with Recommendation No. 1/2009 from the Council for Prevention of Corruption (CPC), published in Series 2 of the Diário da República No. 140 on July 22, 2009.

The Management Risk Prevention Plan, including those related to corruption and associated infractions, is an integral part of the Quality Management System of the Braga City Council. It serves as the formal document for managing the risks inherent to its operations, with the primary objective of identifying risks and the individuals responsible for their management, ensuring a structured approach to risk management within the Braga City Council.

The Braga City Council has chosen to develop and implement a Plan that integrates not only the risks of corruption and associated infractions but also all risks inherent to organizational functioning. This approach takes into account, in addition to the aforementioned legal requirements, the NP EN ISO 9001 (2015) standard – Quality Management Systems: Requirements, which presents the main innovation of a risk-based thinking approach.

STRATEGIC APPROACH

The strategic approach of the Municipality of Braga is based on institutionalizing the principles of sustainability, integrating these fundamental principles into the organizational culture, daily activities, and, above all, in all management actions.



3.1 STRATEGIC MODEL

Braga adopts a participatory strategic model, actively listening to the local community to ensure an inclusive approach in building a sustainable future for the city.

The Municipality of Braga has developed a participatory strategic model to address the challenges of the 21st century. Through extensive consultation with the local community, it has ensured the incorporation of their voices and concerns, strengthening the commitment to build a sustainable future for the city with the participation of all stakeholders.

This participatory approach has reinforced the Municipality's commitment to ensuring that all stakeholders have the opportunity to contribute to building a sustainable future for the city. The strategic model is thus based on four fundamental pillars that guide the Sustainability Report. A comprehensive reading of the megatrends impacting the territory has been conducted, allowing for a deep understanding of the global changes that will affect the city in the short and long term.


The networks in which Braga is integrated were identified, considering the national and international context to promote effective partnerships and mutual cooperation on sustainability issues. The multi-level policies, legislation, and regulations, where Braga has the responsibility to fulfill commitments made

at the regional and global levels, were also taken into account. This perspective ensures adherence to international sustainability principles and standards, strengthening the city's position as a proactive agent in addressing global challenges.

Finally, strategic priorities for Sustainable Development in Braga were established, reflecting the main objectives and goals. These priorities encompass broad areas within Sustainable Development. Simultaneously, the model considers the resource capacity of the Municipality of Braga, including financial aspects, the potential of its workforce, communication capabilities, and the availability of relevant data to support strategic decision-making.

This pragmatic focus has enabled the formulation of viable and realistic actions that strengthen the Municipality's capacity to respond to the various anticipated challenges. The Strategic Plan for Sustainable Development of Braga, resulting from this

collaborative process with the University of Minho, represents the culmination of the efforts of the Municipality and the community to address emerging challenges in an inclusive and effective manner. The first step involved mapping stakeholders, which included identifying and categorizing the various groups that could be affected by the activities and decisions of the municipal administration. This mapping included residents, local businesses, civil society organizations, academic institutions, among others. Through this analysis, it was possible to understand the diversity of actors involved and their respective expectations regarding the sustainable development of the city.

In the second step, the most relevant topics to be addressed in the Sustainability Report were identified. This process considered global sustainability challenges, as well as specific issues that directly impact Braga. The benchmark conducted for the materiality of the 2019 Sustainability Report served as a reference for this analysis, allowing for an evaluation of the continued relevance of the topics already addressed.

Based on the identified topics, the process of engaging the community commenced.

In this third stage, efforts were made to ensure the inclusion and active participation of the mapped stakeholders. Two different approaches were adopted: internal and external.

In the internal approach, representatives from Municipal Departments and municipal companies were invited to participate in thematic workshops and training sessions to align the objectives of the consultation and guide the collection of relevant information. These workshops aimed not only to hear the perspectives of different stakeholders but also to understand the level of importance attributed to each of the topics discussed. The diversity of representatives ensured a holistic approach to the Municipality's sustainable development, allowing for an understanding of the multiple dimensions of the challenges faced by the Braga community.

In the external approach, to make the process more interactive, the previous year's approach was repeated. This approach involved identifying a representative from a particular stakeholder group who would respond to a set of questions through face-to-face interviews, online interviews, or by filling out a questionnaire on a digital platform.

Participation was significant, with 328 responses from 22 stakeholder groups through various channels. Among the 22 stakeholder groups involved, responses were gathered through interviews, in-person surveys, and online questionnaires.

Participation was significant, with 328 responses from 22 stakeholder groups through various channels, including interviews and in-person and online surveys. Additionally, the participation rate was impressive, reaching 94% attendance in the workshops, with a total of 42 participants from 23 distinct organizational units. This broad representativeness strengthened the legitimacy of the consultation process and ensured that the voices of citizens were heard and considered.





Materiality Matrix

To develop a solid understanding of the most relevant issues among organizations and their stakeholders, it is essential to have a set of effective analytical tools that ensure alignment of common interests among various agents. The Engagement Matrix of the Municipality of Braga graphically represents the most relevant sustainability topics of the organization from the perspectives of the Executive and its Stakeholders.



Strategic Council for Sustainable Development

The CEDS of Braga, formed by academic leaders, influential organizations, and dedicated citizens, plays a vital role in shaping the sustainable future of the city.

With representatives from the University of Minho, INL, Portuguese Catholic University, IPCA, CimCávado, CCDR-N, local SDGs, local CESOP, and BCSD Portugal, the CEDS brings together academic knowledge, practical experience, and community vision.

Objectives of the Council:

_ Actively participate in the design and implementation of the strategy for Sustainable Development, continuously evaluating its performance.

_ Discuss relevant municipal issues, issuing opinions and recommendations to mitigate environmental and social impacts.

_ Encourage public participation,

_ Facilitate collaboration and information sharing among CEDS members and the Municipality, promoting a team-oriented work environment.

In November 2023, the Strategic Model for Sustainable Development was presented to the council, outlining goals and actions to achieve the established objectives. 3.3 MEGATRENDS

Envisioning global megatrends for Braga resides in the city's ability to prepare for and adapt to emerging challenges, leveraging opportunities to promote sustainable development, resilience, and the well-being of its residents.

Poluations dynamics

Population dynamics are profoundly impacting cities worldwide. According to recent UN data, over 50% of the global population now lives in urban areas, and this figure is expected to increase to around 68% by 2050. This rapid urbanization has created significant challenges, including a growing demand for infrastructure, housing, transportation, and public services. Furthermore. population aging in some cities is putting pressure on healthcare and social assistance systems. Failure to meet these service demands can lead to social disparities, income inequality, difficulties in accessing education, and disparities in the distribution of employment opportunities, among other issues.

Technologic disruption

According to recent reports, by 2025, it is estimated that around 75 billion devices will be connected to the Internet of Things (IoT). However, local authorities face challenges in fully leveraging this technological transformation. Integrating AI into urban operations, for example, can lead to improvements in transportation, efficient resource management, and more effective services. public Nonetheless. successful implementation requires overcoming obstacles such as data privacy, transparency, and inclusion ensure that technological to advancements benefit the entire community, contributing to smarter, more sustainable, and inclusive cities.

Citizens expectations

According to recent research by the Pew Research Center. over 70% of citizens expect local authorities to improve urban infrastructure and public services. At the same time, political polarization is affecting decisionmaking within local governments, making it increasingly challenging to reach consensus on public policies. This issue was highlighted in the "Global Risks Report 2022," which identified political and social polarization as one of the main threats to social cohesion worldwide. These trends are putting pressure on local administrations. which need to find innovative ways to meet citizens' expectations and promote social cohesion to tackle challenges and build more resilient and inclusive cities.

Cllimate Change

Climate change is imposing significant impacts on cities, creating urgent challenges for local governments. According to the World Bank, by 2050, more than 143 million people could be internally displaced due to the effects of climate change in just three regions (Sub-Saharan Africa, South Asia, and Latin America). The World Economic Forum highlights that an average of 17% of global urban areas are at risk of flooding due to rising sea levels, threatening coastal infrastructures and communities. In light of these figures, the C40 Cities Climate Leadership Group emphasizes the need for urgent and collaborative action among cities to implement adaptation and mitigation solutions, aiming to protect the well-being and sustainability of urban communities.

3.4 NETWORKS

Braga strengthens its integration into local and international networks, fostering cooperation and resource-sharing to promote sustainable development.

ICLEI - Local Governments for Sustainability

ICLEI - Local Governments for Sustainability (ICLEI) is an international organization of local and regional governments committed to sustainable development. Today, more than 1.750 cities, counties, and associations in 84 countries form the ICLEI network. This network also provides technical consulting, training, and information services to empower, share knowledge, and support local governments in implementing sustainable development at the local level. ICLEI's basic premise is that locally designed initiatives can provide an effective and economical way to achieve local, national, and global sustainability goals. In 2019, the Municipality of Braga began its membership process with ICLEL.

EuroCities

EuroCities is a network of major European cities. Members are locally and municipally elected governments from key cities, and it was founded in 1986 by six cities: Barcelona, Birmingham, Frankfurt, Lyon, Milan, and Rotterdam. Today, EuroCities brings together the local governments of 139 of Europe's largest cities and 40 partner cities, governing over 130 million citizens across 40 countries. The network includes six thematic forums, a wide range of working groups, projects, activities, and events, offering its members a platform for knowledge sharing and idea exchange. EuroCities also advocates for the interests of large cities with European institutions and shares leadership positions in various EU-funded projects for cities. It serves as a partnership-sharing network for numerous projects financed by European funds.

Green City Accord - EU

The Green City Accord is a movement of European mayors committed to making their cities cleaner and healthier. It aims to improve the quality of life for all Europeans and accelerate the implementation of relevant EU environmental laws. By signing the Accord, the Municipality of Braga committed to addressing five environmental management areas: air, water, nature and biodiversity, circular economy and waste, and noise. In each of these areas, signatories commit to setting baselines and defining ambitious targets that exceed the minimum requirements set by EU laws within two years of signing; implementing integrated policies and programs to achieve their

targets by 2030; and publishing reports on implementation and progress every three years.

Covenant of Mayors for Climate and Energy

Organized by EUROCITIES under the "Covenant of Mayors for Climate and Energy" commitment, the "Mayor's Adapt - City Twinning" Program is considered the "most important global urban initiative on climate and energy." Braga's participation in this program allows the city to share experiences and enhance its knowledge regarding climate adaptation.

URBACT

For over 15 years, the URBACT program has been the European Territorial Cooperation program aimed at promoting integrated sustainable urban development in cities across Europe. It is a tool of Cohesion Policy, co-financed by the European Regional Development Fund, the 28 Member States, Norway, and Switzerland. URBACT's mission is to enable cities to work together and develop integrated solutions to common urban challenges through networks, learning

3.5 ALIGNMENT OF POLICIES FOR SUSTAINABLE DEVELOPMENT

United Nations 2030 Sustainable Development Goals

The SDGs represent global priorities for the United Nations' 2030 Agenda for Sustainable Development. They outline the global priorities and aspirations for 2030, calling for worldwide action from civil society to eradicate poverty and create lives of dignity and opportunity for all, within the planet's limits. For the Municipality of Braga, the SDGs provide an opportunity to create and implement solutions and technologies that address the world's greatest challenges, helping to align local strategies with global priorities.

Covering a broad spectrum of topics, the executive has utilized the SDGs to shape, guide, and report on its activities while also measuring performance based on a set of benefits. Each year, the city of Braga presents the Municipal Sustainability Index conducted by the Center for Studies and Polls of the Portuguese Catholic University, achieving 69.1% of the Sustainable Development Goals in 2019.



Paris Agreement

The Paris Agreement aims to achieve the decarbonization of global economies and sets one of its long-term goals to limit the increase in global average temperature to well below 2°C above pre-industrial levels, while pursuing efforts to limit the increase to 1.5°C.

As of September 21, 2016, 60 countries had ratified the Agreement, surpassing one of the two criteria, and on October 5, less than a year after the adoption of the Paris Agreement, the ratification by the European Union and some of its Member States, including Portugal, enabled the Agreement to enter into force by meeting the second criterion.

For the Municipality of Braga, the Paris Agreement represents a paradigm shift in the implementation of the Framework Convention on Climate Change, with explicit recognition that only through the collective effort of all can the challenge of climate change be overcome. This Agreement renews hope in multilateralism and underscores the need for a profound decarbonization of the global economy, achievable only through strong ambition at the local government level.

Green Deal - European Union

Climate change and environmental degradation pose existential threats to Europe and the rest of the world. To address these challenges, Europe needs a new growth strategy that transforms the Union into a modern, resourceefficient, and competitive economy, where:

_ There are no net greenhouse gas emissions by 2050;


Economic growth is decoupled from resource exploitation;



4.1 MOBILITY

Improve accessibility, encourage public transportation and promote soft mobility to reduce congestion, pollutant emissions and improve citizens' quality of life. Investing in sustainable mobility has been crucial to Braga.

MANAGEMENT APPROACH

The municipality of Braga has developed a proactive and comprehensive approach to the topic of mobility, always aiming to improve the quality of life of citizens while trying to promote a more sustainable urban environment. The main purpose of this topic was to ensure that all inhabitants had access to an efficient, safe and environmentally responsible transportation system.

During the reporting period, the municipality focused on promoting sustainable mobility solutions, encouraging the use of public transport and investing in the creation of infrastructure for soft mobility. In addition, policies were implemented to discourage excessive use of individual vehicles, promoting shared use and more ecological alternatives.

One of the main activities developed was

the implementation of traffic management measures to minimize congestion and pollutant emissions. The municipality also encouraged the adoption of vehicles of low emissions and cleaner technologies, in line with the objectives of reducing the environmental footprint.

During this period, the involvement of citizens and stakeholders was fundamental, with public consultations and awareness campaigns about the benefits of sustainable mobility. These initiatives aimed to promote a change in mentality and behavior in relation to transportation, building a more conscious and responsible mobility culture in the community.

POLICIES, COMMITMENTS AND OBJECTIVES

Sustainable Urban Mobility Plan of the Municipality of Braga

In recent years, the municipality of Braga has embarked on an ambitious journey towards sustainable urban mobility, as outlined in its sustainable urban mobility plan. The primary objective was the construction of a city and a municipality tendentially "zero carbon", aiming to improve the quality of life of citizens. To this end, an integrated view of the territory, where soil occupation, ways of life and transportation is coherently interconnected.

The strategy focused on the rationalization and recalization of resumes and modes of transportation already installed, promoting the transversality of approaches on this theme. The critical reading of the installed reality was sought, projecting actions that favor the civic increase and pedagogy/ sensitization with the population.


The plan aimed to define structured fields of action that would help the mitigation of the ecological footprint, the reduction of GHG emissions and the correction of dissonant modes and habits. Casa-work and school theme was also incorporated, encouraging rational ways to reduce pendularity and successive car flows.

Comprehensive communication and urban information plans were also designed,

which surpassed directional signaties, favoring the sensitization and education of the population, especially the younger. The promotion of interoperability between the modes of transport and the redesign of public space were also in the focus of the strategy.

Continuous monitoring of strategy progress involved the definition of indicators, data survey and analysis, evaluation of results and necessary adjustments, all with strong involvement of the local community.

This commitment to sustainable urban mobility reflects the commitment of the municipality of Braga to build a more prosperous and harmonious future for its citizens.



Municipal Highway Safety Plan

The Braga Municipal Highway Safety Plan was a strategic initiative designed to promote road safety and reduce accidents on the county roads. Initially, detailed accident data were analyzed to identify higher risk areas and worrying standards. Based on this analysis, preventive and corrective measures were proposed, including improvements in road infrastructure, signaling reinforcement and public awareness campaigns.

The plan emphasized the importance of the inspection and application of traffic laws, with close collaboration from local police authorities. Community participation was encouraged, encouraging complaints of hazardous behaviors and suggestions for road safety improvements.

Modern technologies, such as real -time traffic monitoring and data analysis systems, have been integrated to quickly identify emerging risk areas and respond proactively.

TARG.S clear and performance indicators were established to regularly evaluate the effectiveness of the measures implemented. The continuous involvement of all stakeholders was fundamental to the success of the plan, always aiming to protect all users from Braga's roads.





RESOURCES

TUB

Braga Urban Transport (TUB) is mission to offer sustainable and inclusive mobility solutions, committed to people's well-being and biodiversity preservation. With a view of being a reference in responsible mobility, they focus on the development of more capable people and communities, centered on value creation and the planet. Tub recently announced the acquisition of 30 new electricity -powered buses, gradually replacing older vehicles to fossil fuels. With 18 of these buses in operation since 2022 and the remaining planned by 2023, the goal is to reach a fully electric fleet by 2030. In addition, they started renewing static information in about 2,000 pounds of buses, aiming to improve quality and the Simplicity of information provided to customers, thus contributing to a more efficient and friendly transportation experience for all.s.



Transportation Coordinator Center of Braga


The CCTB - Braga Transportation Coordinator Center is a vital infrastructure for parking and stopping passenger transport, including express and international services, as well as boarding and disembarkation of passengers. Its objective is to ensure non -discriminatory access and equal opportunities for all operators, offering quality facilities, ticket office, service systems and information to the public. Managed by the Braga City Council, it aims to provide an efficient and quality public transport service, suitable for the needs of the population, and contribute to the planning and fluidity of urban traffic.

Urban laboratory

The Urban Innovation Laboratory (LIU) was created to boost innovative interdisciplinary projects on urban mobility and sustainability. In partnership with universities and local companies, LIU promotes the co -creation of solutions for urban challenges, aiming at a smarter and sustainable city. This space of collaboration and experimentation contributes to the development of pilot projects and the promotion of knowledge about sustainable urban practices in Braga.





Electric Bicycle System Shared

The municipality of Braga provided a system

of shared electric bicycles, starting with

60 bicycles, as part of its commitment to sustainable mobility. This initiative has

INITIATIVES

Implementation of Bus Rapid Transit

The municipality of Braga invested about 100 million euros in the implementation of the Bus Rapid Transit (BRT) system, funded by the recovery and resilience plan. This system, mainly operated on its own channel, aims to improve urban mobility by connecting the city center to several traffic generating poles and the railway station. With decarbonized vehicles, it is intended to reduce CO2 emissions and promote a sustainable alternative to individual transport.




Bicification

Braga joined the project "Bicification - The Future in Two Wheels", rewarding 500 bicycle users for the distances traveled in the city. Participants accumulate financial incentives per kilometer traveled, with a maximum of ≤ 1 per day and ≤ 28 per month. Through a mobile application, it is possible to monitor bicycle travel, map favorite routes and promote smooth mobility, contributing to the reduction of CO2 emissions.



Infias Node Intervention

Infias node intervention aims to improve traffic fluidity and road safety in one of the city's most congested areas. Funded by the Northern Norte2020 Regional Operational Program, the initiative includes land expropriation and the requalification of road infrastructure, contributing to more efficient and sustainable mobility in Braga.



Braga Business Mobility Pact

The Braga Business Mobility Pact (PMEB) is an initiative promoted by BCSD Portugal and Braga City Council, with the objective of promoting more sustainable mobility in the municipality. With the adhesion of 50 companies, the pact presents 28 concrete actions to reduce carbon footprint and improve the quality of life of citizens, contributing to a greener and more inclusive city.

School mobility

"Eu já passo aqui"

The project "Eu já passo aqui" aims to make pedal crossings more affordable, with podotal floors in various streets of the city. Funded by the Northern Norte2020 Regional Operational Program, the intervention covers areas close to schools and other public facilities, ensuring safety and comfort for citizens, especially for the invisuals. With a period of execution of 150 days, this initiative contributes to more inclusive and sustainable mobility in Braga.



School Bus

School Bus is an initiative that aims to reduce car congestion near Braga urban schools, promoting sustainable mobility and student safety. The service covers several schools in the city and offers calls from four main entrances of Braga, encouraging the use of environmental transport means of the environment. This measure contributes to the quality of life of citizens and the promotion of a more sustainable city.



Performance

Ciclo Expresso

The CicoExpresso project, launched in 2023 by the municipality of Braga, is a free service that encourages children to go to the bicycle school, accompanied by adult monitors, promoting sustainable urban mobility. With three participating schools, the CycloExpresso establishes routes and times defined to ensure safety. In addition to promoting the use of bicycles as a healthy and fun means of transport, the project aims to develop children's autonomy, stimulate motor and sensory skills, and raise awareness of the importance of sustainable displacement modes.



Aprender a Ciclar

The "Aprender a Ciclarr" project promotes sustainable mobility, educating children and communities about the benefits of bicycles as a means of transport. Implemented with the European Week of Mobility and the "Areas +" project, it focuses on non-formal education in schools and communities. Activities replace spaces for motor vehicles with areas for children, encouraging their bicycle use. The goal is to improve quality of life and transform behaviors for sustainable development. The program aims to form safe and responsible urban cyclists, promoting healthy and conscious habits of active mobility.

PediBus

The project PediBus project promotes sustainable urban mobility, focusing on safety and air quality by encouraging walking on school routes. Launched in 2018 during the European Mobility Week, the pilot project involved several schools. It is currently being implemented in three schools as part of a transportation fund candidacy. Adults monitor children along the way, ensuring security. The objective is to provide a pedestrian travel support service to schools, aiming at humanization and equitable redistribution of urban space.

Kiss & Go


The municipality of Braga developed the Kiss & Go pilot project in the city center, in 2017. This project aims to create places intended for the delivery of children in the immediate vicinity of schools, which will be done briefly. Currently the municipality of Braga has been spreading this project throughout the county. This project aims, not only, the elimination of long -term parking with schools, but also of crossing traffic that is generated through parking availability. This allows the rapid access of children who even have to move to the car school, reducing pollution and traffic in the surrounding schools.



Shared Green Deal

The Shared Green Deal project implements "Urban Mobility Laboratories" in three schools, involving young people and members of the school community. Working in co -creative forums, they share knowledge about travel to the school and explore sustainable alternatives. Objectives include changing behaviors to sustainable mobility in school travel, supporting institutional strategies for intelligent and sustainable mobility, formulating political recommendations, and creating specific solutions for each school. The project seeks innovative and adapted solutions to the local context, promoting the participation of young people and the school community in building a more sustainable environment.





Decarbonization of the Tub fleet

The prominent initiative "Towards Decarbonization: Renewal of the Tub Fleet" represents a significant commitment from the municipality of Braga to the transition to a carbon emissions economy and the promotion of sustainable mobility in the region. With a total eligible investment of 14,443,233.01 € and substantial financial support from the European Union and national and regional public source, this project covers three distinct phases over a four -year implementation period.

In the phase, called "Tub 2020", the urban transport of Braga (TUB) started an innovative environmental strategy, focused on the renewal of the collective public transport vehicles fleet. With an investment of \notin 4,985,350.34, 32 "clean buses" were purchased, 25 with GNC propulsion and 7 with 100% electric propulsion. This measure resulted in a significant reduction in the Middle Ages of the fleet, increasing energy efficiency and decreasing polluting emissions, aligning with the most demanding environmental standards.

The phase, "Tub 2023", reinforced Tub's environmental strategy with the introduction of six more 100% electric buses, partly funded by the European Union. This investment of € 1,737,501.67 resulted in a primary energy savings of 73.66% and a reduction of 253.24 tons of CO2EQ, contributing significantly

to the decarbonization of the operation of urban transport from Braga. In addition, the replacement of diesel vehicles with more sustainable alternatives promoted a substantial improvement in the quality of air and quality of life of citizens.

Finally, the phase, also designated "Tub 2023", represents an additional step in the TUB decarbonization strategy. With an investment of € 8,720,382.00, financed by the European Union Cohesion Fund, this operation covers the replacement of 30 diesel buses with 100% electric vehicles. The expected results include the total reduction of CO2 emissions and the promotion of sustainable mobility, contributing to the construction of a greener and more resilient city. In short, the initiative "towards decarbonization: renewal of the Tub fleet" reflects the commitment of the municipality of Braga to environmental protection, the promotion of sustainable mobility and the improvement of the quality of life of its citizens. By investing in the renewal of the public transport fleet with cleaner and more efficient vehicles, Braga is leading for example in the fight against climate change and building a more sustainable future for all.










Awards

Sustainable Mobility Award of the European Mobility Week 2022

Braga won the Sustainable Mobility Award of the 2022 European Mobility Week, standing out for the active promotion of sustainable urban mobility. Councilwoman Olga Pereira emphasized the municipal commitment to greener mobility, including the expansion of bike lanes and the acquisition of more electric buses. Recognition was the result of initiatives such as the closing of streets to traffic, playful activities and awareness sessions. Braga surpassed finalists such as Sofia and Zagreb with a diverse program, including accessibility projects, intermodal tours and conferences. This European award highlights local authorities that stand out in the promotion of sustainable mobility.



Business and Braga Mobility Pact

Braga won the National Sustainability Award in the Sustainable Mobility category by the Braga Business Mobility Pact. Launched in 2022, it has 38 companies compromised by 2023 in measures for more green and inclusive mobility. Initiative based on 2019 report of the City Council, which highlights mobility as a cause of 65% of emissions. With 28 proposed measures, including the acquisition of electric vehicles, it is expected to avoid 582 tons of CO2/year. The ceremony took place at the Great Conference Business Sustainability 20 | 30, recognizing projects aligned with sustainability.







4.2 HOUSING

Housing and social support is fundamental to ensure the well-being of the citizens of Braga. The availability of accessible housing and adequate housing policies are essential to promote social inclusion and quality of life

MANAGEMENT APPROACH

Braga has invested in housing programs and social support to face housing challenges. Through partnerships with public and private entities, measures such as the construction/ rehabilitation of social housing and support for needy families were implemented. The municipality of Braga has played an active role in promoting housing solutions ensuring that the needs of the most vulnerable are met.

In addition, social support programs have been developed to provide assistance to specific groups, such as elderly people, people with physical limitations and needy families. This integrated approach aims to create a more inclusive city, where everyone has access to decent and appropriate conditions, and the necessary social support to prosper. The municipality of Braga remains committed to developing these policies and programs that promote equity, social cohesion and the well-being of all its citizens, thus contributing to sustainable development and a more fair and solidary city.

POLICIES, COMMITMENTS AND OBJECTIVES

Local Strategy for Housing

In the past, the municipality of Braga has shown an unequivocal commitment to the right to housing, reflected in the approval and implementation of the Local Strategy for Housing (LSH). This strategy, which was atualized in 2023, emerged in response to the housing needs identified in the county, reflecting the concern in ensuring decent housing conditions for all citizens.

ELH was conceived based on a comprehensive diagnosis of local housing needs, allowing you to identify priority areas of intervention. Since then, it has been the subject of periodic revisions to ensure its update and relevance to the evolving social and economic dynamics.

The main objectives of LSH have been:

_ Respond effectively to families in serious housing deficiency, providing them with adequate housing conditions;

 Ensure access to housing for those who find no response in the conventional real estate market;

 Promote the rehabilitation of the building and sustainable urban development as the main intervention strategy; _ Foster social and territorial inclusion, as well as the diversification of available housing options.

Within this framework, specific policies have been delineated to ensure the implementation of these objectives, including programs such as lease supported, sub-barrexing, direct lease support regime and shared residency regime.

The LSH thus represents a solid commitment of the municipality of Braga to sustainable development, ensuring that housing is not only a basic need, but also a fundamental right for all its citizens.



Regulations for Housing Support

The municipality of Braga, aware of the importance of guaranteeing access to housing for all its residents, has implemented a housing support regulation that includes various support modalities, adapted to the different realities and needs of its citizens. Supported lease is one of the aspects of this regulation, allowing Bragahabit's dwellings to be available at affordable prices, calculated based on the income of household aggregates. This measure aims to ensure that even families with minors resumes have access to a dignified housing and suitable for their needs.

In addition, the municipality has also promoted the subbar-reaching, through which housing leased by Bragahabit are attributed to citizens in economic and financial vulnerability. This regime, which follows the same guidelines as lease supported, aims to provide a temporary housing solution for those who are in a greater situation.

The direct support regime to lease is another important measure of this regulation, consisting of the assignment of financial support to comply with the monthly payment of income in free income lease agreements. This initiative aims to relieve the weight of housing expenses for household aggregates with minors.

Finally, the shared residency regime (RRP) offers an alternative solution, giving in bedrooms in housing under Bragahabit, accompanied by permanent social support. This modality aims to promote the sharing of resumes and the creation of cohesive

and supportive communities.

The Braga Municipality Housing Support Regulation thus reflects the municipality's commitment to ensure universal access to housing, contributing to the construction of a fairer and more inclusive society.

BRAGAHABIT, Braga Municipal Company for Housing

Bragahabit is a key piece in the livestock scenario in Braga. As a municipal company, it has played a crucial role in rehabilitation of the urban building, promoting access to decent and conditioned housing for all citizens. Since its inception, Bragahabit has been dedicated to the management of social support to housing, with a special focus on the most disadvantaged citizens.

Through its mission centered on reducing social and economic difficulties, Bragahabit has sought to ensure housing solutions to all strata of society, especially for those who live in unworthy conditions and have no financial capacity to support fair housing costs.

In addition, Bragahabit is not limited to housing provision. It also plays an important role in social inclusion, transforming the public space and providing fair and conditional conditions for all citizens. This focus is not only intended to improve housing and social quality, but also promote the health and well-being of the population.

In its search for environmental sustainability, Bragahabit is aligned with the policies and vision of the municipality of Braga. The company actively works to combat energy poverty through the creation of rehabilitation solutions that promote healthy inner and exterior conditions, resulting in energy savings and greater resilience in the face of fluctuations in energy costs. This approach reflects Bragahabit's commitment to sustainable development and the long-term well-being of the Braga community.

ROOF PROJECT

As an integral part of the Roof - Ending Homelessness project, funded by the European Union, Braga stands out as one of the leading cities in the integration of homeless people. This project adopts innovative housing solutions, promoting social inclusion and offering opportunities for those who need it most.

By participating in this project, the Municipality demonstrates an active commitment to

sustainable development and social justice.



Porta de Entrada Program

The Braga Porta de Entrada program is a humanitarian initiative that offers urgent accommodation to refugees and people who have lost their homes due to exceptional circumstances. This initiative not only responds to the urgency of basic housing needs, but also promotes integration and solidarity with those who face significant challenges. By providing a safe and welcoming home, the gateway program reflects Braga's commitment to humanity values and sustainable development.



Urban cycle policies and water management in Braga

The Public Water Supply Service Regulation and Urban Water Sanitation Sanitation and the Braga Municipality Industrial Discharges Regulation represents a central and fundamental part of urban cycle policies and water management in the city. This regulation establishes the guidelines and normatives that guide the provision of drinking water supply and wastewater treatment services, ensuring the quality, safety and sustainability of these services to all citizens.



Water supply

Responsible for capturing, treatment, adduction and distribution of water to the municipality of Braga, AGERE is the entity responsible for ensuring access to a drinking water supply with excellence and safety. About 32,000m3 of drinking water are provided daily, attesting to the commitment to quality and water availability for the citizens. The Braga supply system consists of four essential steps. It begins with the capture in the Cávado River, followed by treatment at the Water Treatment Station (ETA), located on the bouncing bridge. Subsequently, treated water is transported, stored and distributed with rigor and efficiency.

Water safety for human consumption is an absolute priority for AGER, reflected in concrete actions to ensure product compliance. Through the Water Quality Control Program (PCQA), fully aligned with the current legal regulations, periodic analyzes are performed that attest to the quality and safety of the supplied water. The results of these analyzes are available quarterly, strictly complying with legal requirements and promoting transparency and confidence with the population.



Sanitation

The treatment of wastewater in Braga is conducted through an efficient and careful process, consisting of four distinct steps: preliminary and primary, secondary and tertiary.

In the preliminary and primary step, physical separation processes are applied to remove suspended solids of various dimensions, as well as other waste such as food remains and hygiene products. Separation is performed through harrowing, filtration and sedimentation processes, ensuring the effective removal of these materials. The resulting primary mud is referred for specific treatment, while the effluent goes to the subsequent steps.

In secondary treatment, wastewater is subjected to biological treatment, where bacteria degrade dissolved organic matter. Subsequently, biological mud is separated by sedimentation, being referred for proper treatment. The treated effluent is discharged after this process.

The tertiary stage consists of ultraviolet radiation disinfection, ensuring a level of microbiological quality that allows the reuse of water for various purposes, such as watering of green spaces and washing car and floors. Lamas, after proper treatment, are intended for agriculture, playing an important role as fertilizer or for energy enhancement.



Requalification of water lines

The strategy of appreciation and rehabilitation of Braga water lines is an essential initiative to mitigate the impacts of rainwater and climate change, aligning with the municipal strategy of adaptation to climate change. This strategy comprises the identification and prioritization of measures and investments aimed at reducing the vulnerability of the city in relation to water resumes.

Strategic actions include interventions that promote sustainable management of water resources, such as the recovery of degraded areas, the implementation of green infrastructure and the promotion of sustainable drainage practices. The goal is to create a more resilient urban environment adapted to climate challenges, ensuring the preservation and sustainable use of water resumes for future generations.

AGERE EM

AGERE emerged from the transformation of municipal water and sanitation services into a municipal public company, marking a turn to the management of water resources in Braga. Since 1999, it has been a key pillar in the provision of community essential services, with a clear view of promoting sustainable development.

AGERE has taken over as a majority company company, putting the collective interest above all. With a wide portfolio of clients and a significant monthly revenue, it has become a national example of efficient management and commitment to the quality of life of citizens.

Investment in human resources and infrastructures reflects AGERE's commitment to providing a public service of excellence, combining innovation, sustainability and social responsibility in all its activities. The company has been a pioneer in the development of projects related to the circular economy, demonstrating a firm commitment to the preservation of natural resumes and the well-being of future generations.



Sanitation

The Braga Sanitation System is an intricate network, consisting of 15 treatment systems, 16 WWTPs (wastewater treatment stations) and 38 lift stations. With a sanitation network extension that totals 1,024km, Agere plays a crucial role in the management and proper treatment of wastewater of the municipality.

The diversity of treatment systems, from lame -activated lames, reflects AGERA's holistic approach in the search for effective and sustainable solutions for urban sanitation. This complex network ensures not only the removal of solid and organic waste from wastewater, but also promotes the protection of the environment and the preservation of local water resumes.

Urban Water Lines

The urban lines of water, represented by the Rio Este, the Torto River and the Ribeira de Panoias, along with the associated riverside ecosystems, play a vital role in the urban ecosystem of Braga. In addition to contributing to the region's biodiversity and natural beauty, these water lines provide leisure and recreation spaces for local inhabitants, promoting greater contact with nature and contributing to the well-being of the community. The municipality of Braga has made significant efforts on the requalification of these lines, integrating them into the urban environment in a harmonious and sustainable way. In addition, rehabilitation projects have been carried out in Xonas of the banks of the Cávado River, expanding the areas of enjoyment and preservation of this important natural resource.



River Beaches

Braga is gathers a number of river beaches, such as the Fluvial Beach of Merelim S. Paio, the Ponte do Beso river beach and the navarre leisure area. These places offer unique opportunities to enjoy the natural environment, practice outdoor activities and relax in picturesque scenarios. River beaches are not only a leisure resource, but also a testimony of Braga's commitment to the preservation and appreciation of their water resources, providing the community sustainable and affordable recreation spaces.


Efficient use and management of water

Braga implemented a proactive approach to efficient water management, using advanced technologies and innovative practices. Daily, the city monitors flows and pressures throughout the supply network, identifying and correcting anomalies. It also invested in maintaining pressure reducing valves and continuous analysis of network pressures, ensuring sustainable and responsible use of water resumes. **River beaches with blue flag**

The recognition of three blue flag river beaches highlights Braga's commitment to environmental excellence and the quality of its bathing zones. The continuous bet on the improvement and development of these recreational areas reflects the municipality's commitment to offer safe, clean and attractive spaces for inhabitants and visitors, promoting sustainable tourism and the valorization of natural resumes.

Rainwater Network Registration and Cleaning of River Margins

Braga registered more than 100 kilometers of rainwater network, strengthening the control of discharges in the river and protecting the local water resources. In addition, it has invested in cleaning and disappearing the river margins, ensuring the conservation of natural habitats and the prevention of negative environmental impacts.



Archaeological and hydrogeological studies of the seven source

In the previous study of the Seven Source Detail Plan, archaeological and hydrogeological studies were conducted. Archaeological studies have revealed significant traces since the Roman period, while hydrogeological studies have evaluated water productivity and quality in six locations in the system. This comprehensive approach provides crucial insights on the history and sustainable management of the seven source capture system in Braga.ma de captação das

Rios project

The Rios project, adopted by the municipality of Braga, involved the community in the conservation of river spaces, promoting environmental awareness and active participation. Through the adoption of river sections for local entities and periodic visits to monitor and improve river conditions, Braga demonstrated a solid commitment to the preservation of their water resumes and the promotion of biodiversity.



Requalification and Renaturaization of the Torto River and Ribeira de Panoias

The partnership with the Portuguese Environment Agency and the Government for the requalification of the Torto River and Ribeira de Panoias demonstrates a serious commitment to the solving of persistent environmental problems. This initiative not only aims to mitigate the risks of floods and pollution, but also to restore riverside ecosystems, promoting biodiversity and the quality of life of local communities.



Civil Protection Operational Team -Environment

The creation of the Civil Protection Operational Team - Environment has reinforced the ability to respond to environmental emergencies and the protection of Water Resources in Braga. This dedicated team conducts inquiries of denounced discharges and regular verifications of the margins of the water lines, ensuring the safety and preservation



AGERE was recognized for the sixth consecutive year as the Portuguese Municipal Company with the best economic result, highlighting 137 companies. According to a study by the Center for Research on Accounting and Viceagem at the Polytechnic Institute of Cávado and Ave, with the support of the Order of Certified Accountants and the Court of Auditors, the distinction reflects Agere's strict management strategy, focused on resource efficiency, Cost reduction and improvement of services. The company was praised for water quality, accessibility of services and significant tariff reduction for the citizens of Braga.





4.4 SUSTAINABLE URBAN DEVELOPMENT

The promotion of the balance between growth and environmental preservation, ensuring quality of life for citizens and preservation of the city's historical-cultural heritage is essential for the municipality of Braga.

MANAGEMENT APPROACH

Braga has adopted an integrated approach to sustainable urban development, based on strategic and participatory urban planning. Investments in green infrastructures such as parks and leisure areas promote urban biodiversity and mitigation of climate change effects. In addition, sustainable mobility policies, such as expansion of cycle paths and efficient public transport, reduce dependence on motor vehicles, improving air quality and reducing congestion. The rehabilitation of historical buildings and the promotion of sustainable architecture preserves the cultural identity of the city. The approach to Braga's sustainable urban development has been a basis for promoting local economic development through incentives for business and economy. Municipal Master Plan - PDM

The PDM is a fundamental territorial management instrument for municipal management, since it establishes the territorial development strategy, the municipal policy of soils, the planning of territory and urbanism, the territorial model, as well as interdependence relations with Bordering municipalities and European, national and regional programs. The second revision of the Braga Municipal Municipal Plan came into force with the publication of NOTICE No. 11741/2015 in Diário da República 201, 2nd grade, of October 14, 2015 and was available for consultation by 2023.

The Municipal Master Plan is a constantly evolving process in a context of significant social, demographic, territorial changes, and the PDM revision is underway. This context forces the adequacy to new challenges and opportunities, with its primary objective to reinforce the affirmation and resilience of the territory and the promotion of the quality of life of its citizens.

Urban Rehabilitation Areas (ARU's)

Urban rehabilitation is a priority for Braga, aiming at the revitalization of degraded areas and improving the quality of life of citizens. In 2023, a review of ARU's was performed, resulting in the creation of two new areas: Aru Central Space and Aruu expansion of the city. ARU Espaço Central focuses on the requalification of the Historic Center, implementing a systematic urban rehabilitation operation through the Strategic Urban Rehabilitation Program. In turn, ARU expansion of the city covers areas adjacent to consolidated urban areas, promoting a careful intervention aligned with Braga's rehabilitation and dynamization strategy, through a simple urban rehabilitation operation and the urban rehabilitation strategy.

Urban Innovation Laboratory (LIU)


Braga Urban Observatory

Simplex of urban licensing

The municipality of Braga implemented the simplex of urban licensing to speed up and simplify authorization processes for sustainable projects. 


Public green space




MANAGEMENT APPROACH

POLICIES, COMMITMENTS AND OBJECTIVES

Afforestation plan

The Municipality of Braga undertook a significant effort in the formulation and implementation of the municipal afforestation plan. This plan was conceived in close collaboration with various entities, in order to provide an integrated and directed approach to streets, avenues and other spaces in the city. Considering the specific characteristics of the urban environment, such as sun exposure, wind and road circulation, the plan sought to optimize public afforestation, promoting the sustainability and improvement of the urban environment.

The elaborated strategic document reflected on the situation in the city and outlined a short, medium and long term plantations and substitutions program. This program aimed not only at aesthetic improvement, but also the promotion of ecosystem services provided by trees, such as support, regulation and cultural benefits. The plan identified the types of afforestation to maintain, replace, discontinue and new types to create, considering the specific needs of each urban area.

Given the safety of people and goods, the municipality of Braga has also been conducting reports over the urban grove phytosanitary state, sometimes the need for pruning and slaughtering trees at risk of falling. Urban trees slaughter only occurs when there is potential and proven danger, by biomechanical and or phytosanity analysis, elaborated by a technician with a formation provided for in the law, the existing grove causes damage to its surroundings, namely in people, vegetation, constructed structures and other goods or whenever this is justified, considering mobility or implementation of the choice of species. Whenever the need for tree slaughter occurs, the municipality promotes, in the eras its own plantation, the replacement of trees shot down with younger ones of the same genre. management of the forest, PMDFCI Braga defined five strategic axes of action. These included increased territory resilience to forest fires, reducing the incidence of fires, improving the effectiveness of fires and management, the recovery and rehabilitation of affected ecosystems, and the implementation of an effective organic and functional structure to coordinate to coordinate These actions.

By promoting sustainable forest management and fire prevention, the municipality demonstrated a tangible commitment to the protection of the environment and the promotion of sustainable development in Braga. These policies reflect a comprehensive and integrated view to ensure the preservation of natural resumes and community safety.





Action Plan for Climate and Sustainable Energy

The municipality of Braga, through the signing of the mayor pact for climate and energy, made a commitment to support the implementation of TARG. From 40% greenhouse gas reduction by 2030, the reduction of energy poverty and the creation of a long -term vision to achieve climate neutrality by 2050. This process starts from a sustainable development approach, supported globally globally By the 2030 Agenda of the United Nations and the respective sustainable development objectives, in a joint approach to mitigation and adaptation to climate change. In this context, considering the strategy for sustainable development and the path already developed by the Municipality, it is established as a more ambitious local objective, to reduce its CO2 emissions by at least 55% by 2030.

Thus, it is expected to accelerate the carbonic neutrality of the territory in an equitable and sustained manner. In order to comply with this commitment, the Municipality is committed to defining various energy sustainability measures that make up the Sustainable Energy and Climate Energy Plan (PAESC).

The Paesc identifies any situations with

potential for improvement, based on continuous evaluation of indicators. These indicators are defined in accordance with the recommendations of the mayor pact and the Joint Research Center. This plan presents an emission reference inventory, which aims to quantify the energy consumption and CO2 emissions inherent to the activity developed in the Municipality (referring to 2008) and an assessment of risks and vulnerabilities to climate change.

Public lighting

Public lighting in Braga is a priority for the municipal administration, reflecting not only concern for citizens' safety and well-being, but also a commitment to energy efficiency and sustainability. The public lighting system in the city is modern and efficient, composed of low energy consumption LED luminaires, strategically distributed in streets, avenues, parks and residential areas. In addition. the transition to intelligent public lighting has been a priority in Braga, incorporating sensing technologies and automation to adjust brightness as used, thus reducing energy waste. Regarding public lighting, the municipality has implemented important measures in recent years. Initially, by 2020, there was a replacement of conventional lamps with LED technology in various areas of the city, aiming to reduce energy consumption. This transition has allowed a significant reduction in energy consumption and a longer service life of the lamps, contributing to a lower need for replacement and less waste. In 2021, the municipality continued its energy efficiency strategy, expanding the use of LED lighting in more public streets and spaces. This measure not only improved energy efficiency, but also contributed to the reduction of carbon emissions, as LED lamps consume less electricity. The following year, in 2022, the municipality of Braga advanced with the implementation of intelligent

public lighting management systems. These systems allow remote control and monitoring of light function, adjusting the light intensity as needed, which results in more efficient use of energy and the reduction of waste. In addition, in collaboration with e-Redes, 6,225 LED luminaires were installed during the 2020s, 2021 and 2022. These actions allowed a significant reduction in energy consumption over the years.

Municipal fleet

The Braga Municipal Fleet is diverse and adapted to the needs of the city, comprising a variety of vehicles for urban services, personnel transportation, infrastructure maintenance and waste collection. The municipal administration is committed to the transition to more sustainable vehicles, such as electric and hybrids, aiming to reduce greenhouse gas emissions and improve air quality in the city. In addition, preventive maintenance programs and efficient management of the fleet has been implemented to ensure vehicle operation and durability. With regard to municipal fleets, the municipality of Braga has implemented measures for the energy transition, including the acquisition of electric vehicles (EV). Until 2023, 10 EV vehicles were purchased, representing about 6%.





Municipal buildings

Municipal buildings in Braga are designed and maintained with high standards of energy efficiency and sustainability. They serve as an example of good environmental and architectural practices, incorporating green construction technologies such as thermal insulation, efficient heating and refrigeration systems, LED lighting, and solar energy use. In addition, many of these buildings are multifunctional, offering spaces for community, cultural and administrative activities, promoting interaction between citizens and municipal services.

Regarding municipal buildings, the municipality has promoted interventions to increase energy efficiency, including rehabilitation of coverage, outer walls, glazed spans, ventilation systems and stock boxes. These interventions aim not only to reduce energy consumption, but also the increased thermal comfort of occupants.

in renewable energy production facilities, such as solar parks, wind turbines and hydroelectric power generation systems, taking advantage of the natural resources available in the region. These facilities not only contribute to the reduction of carbon emissions, but also generate local jobs and promote the city's energy resilience. In addition, awareness and education programs are implemented to involve citizens and local companies in the adoption of sustainable energy practices. Additionally, the municipality of Braga has installed a installation of photovoltaic panels in Braga Sapadors Firefighters, with a production capacity of about 36 kW. This installation went into operation in 2022 and contributed significantly to the production of renewable energy in the municipality.

These measures and initiatives demonstrate the commitment of the municipality of Braga to energy efficiency, decarbonization and the transition to a more sustainable and environmentally friendly city.

4.8 ECONOMIC DEVELOPMENT AND EMPLOYMENT



4.9 WASTE MANAGEMENT AND CIRCULARITY

Waste and circular management has been fundamental to Braga, promoting environmental preservation, reducing pollution and encouraging a sustainable economy. The city seeks to minimize waste, stimulating the reuse of resumes and the adoption of circular practices.

MANAGEMENT

The municipality of Braga has adopted a multilevel approach in the formulation of waste management policies and circularity in all phases of the material life cycle.

The management of urban waste in Braga is governed by the Municipal Regulation of the Urban Waste Management Service, under the jurisdiction of the municipality of Braga, with competence delegated at AGERE -Braga Water, Effluents and Waste Company, E.M. This entity, according to its statutes, has as its main objective the management of urban waste and public cleaning, being the municipality of Braga the starting entity, responsible for the law to ensure the provision of the urban waste management service in its territory.

In the phase of selective collection, screening, appreciation and elimination of urban waste, Braval is the responsible manager, acting as a holder in the name of the Portuguese State. In turn, AGERA is in charge of the selective collection of special urban waste flows not covered by Braval. To ensure efficiency, infrastructure investments were made for selective collection and recycling centers, encouraging Source reduction practices. The municipality collaborates with other municipal and regional entities in integrated solutions for the process of collection, treatment, appreciation and final disposal of waste.

Constant monitoring of environmental impacts is performed, with corrective measures when necessary. Awareness programs increase awareness of waste reduction and circular economy. Partnerships with local companies promote the reuse of materials. Innovative technologies are adopted to optimize waste collection and treatment, minimizing environmental impacts. This approach not only aims at efficient waste management, but also the promotion of a more sustainable community in Braga.

Municipal Regulation of the Urban Waste Management Service

The creation of the Municipal Regulation of the Urban Waste Management Service establishes the foundations for efficient and responsible management of waste in the municipal area. This regulation clearly defines the rules for the provision of the urban waste management service, attributing to AGREA the sole responsibility for its execution. Under the aegis of applicable legislation and delegated management contract, Agere has prepared strategies, organized operations and promoted the collection and transport of urban waste in Braga. This approach also included integrated waste management, covering the removal, referral and marketing of valuable products, except in cases where the selective collection was the responsibility of Braval.

With this regulatory approach, the municipality of Braga seeks to ensure not only the effective waste management, but also the promotion of environmental sustainability. The Municipal Regulation of the Urban Waste Management Service reflects the historical commitment of the municipality of Braga to sustainable development, establishing the foundations

for efficient, responsible and integrated waste management, always in the search for a cleaner, safe and sustainable future for the present and future generations.

Urban waste collection system in the municipality of Braga

Agere has implemented a new urban waste collection system, replacing the old door -to -door method with a proximity collection system. This included the installation of underground and surface containers on public roads, as well as its regular washing and the optimization of the car park. This approach not only modernized waste management infrastructure, but also contributed to improve the city's image and promote public and environmental health, reflecting the commitment of the municipality of Braga to sustainable development. The widen container network allows the disposition of waste to translate into a simple, fast and practical task. From 100 meters, in residential areas. a container of undifferentiated waste is available.

It covers from screening to the appreciation of different types of waste, such as biodiesel and biogas. In partnership with the Braga Business Association, the Braga City Council presented an ambitious candidacy, covering 927 consumer trade and services establishments in 52 arteries of the Braga Historic Center. The project, with an eligible eligible investment of 1.5 million, aims to value and digitize street trade, promoting the creation of online platforms, internet access points, sales management and orders delivery, among other actions. This joint effort aims to streamline local commercial centers, making them more attractive and technologically advanced, aligned with contemporary consumer trends and the requirements of digital economy.



EIT Digital Braga Satellite



In addition, initiatives to encourage continuous teacher education and technology integration into the classroom have been prioritized. The goal is to build an educated community, critical and prepared for the challenges of the 21st century, thus strengthening the pillars of sustainable development in Braga.

POLICIES, COMMITMENTS AND OBJECTIVES

Educational Cherter

The Municipality of Braga guides its environmental education strategy through the Educational Charter, a strategic document that aims to adapt educational policies to the local reality. It seeks a consistent and up-todate approach to face educational challenges, promoting cohesion and environmental, socioeconomic and territorial sustainability. The strategic vision, aligned with the letter of educating cities, emphasizes equity in access to education and the construction of an inclusive school.

The Educational Charter reflects the commitment to a cross -sectional education to all local policies, integrating the sustainable development objectives. Strategic objectives derive from the need for a more inclusive and dynamic school community, promoting cooperation, respect for difference and effectiveness in resume management.

Four strategic axes outline the approach: promotion of inclusive school; Physical quality and educational success; cohesive and participatory educational policy; Adult education and lifelong training.

The updating of the Educational Charter aims to diagnose the socio -educational state, characterizing the municipal network. Strategic lines seek to guide principles, objectives and suggestions for revision, aiming at cohesion and socioeconomic and territorial sustainability.

The diagnosis and its conclusions underlie the next phase, where the municipality, in partnership with the University of Minho, develops an environmental education strategy. This search for concrete targets, being presented until December 2023, scheduled for approval at the Municipal Assembly.



Local Educational Project

For the municipality of Braga it is essential to privilege the investment in the formation (formal and non -formal) of citizens, debating and coordinating - transversely the interventions of the different entities, partners and educational agents, respecting the principles of the Educating Cities Charter. Harmonizing a set of integrated policies, the opportunity is to homogenize the prosperity of the territory structure and the (dis) involvement of the community in educational and municipal intervention. In this desiderate, the local educational project is one of the mechanisms that guide municipal intervention in the educational component, associated with a strategic development plan.



School support

The municipality of Braga assumes a comprehensive commitment aimed at the well-being and efficiency of educational institutions. Prioritizing school meals, promotes healthy eating to cultivate appropriate habits. In the maintenance of the building, guarantees conditions conducive to teaching, performing interventions for safety and comfort. School transport is managed with commitment, aiming at access, inclusion and equality. School social action implements policies to support students in unfavorable socioeconomic situations, promoting equality in educational access. Non -teaching staff is recognized as fundamental, and the municipality ensures fair labor conditions, valuing its role in the educational community. Braga undertakes to provide educational institutions that offer not only educational quality, but also a safe

and inclusive environment for all students.

Municipal Council of Education

The municipality of Braga adopts an educational policy centered on collaboration with various educational agents, promoting innovative and mobilizers projects through the dialogue and sharing of resumes. In this context, the Braga Municipal Education Council is a key piece. not only for legal requirement, but as a civic commitment. Recognizing the citizens as protagonists, not only recipients, the Council acts as an instance of coordination and consultation in the formulation and implementation of the municipal educational policy. Its creation reflects the search for greater efficiency and effectiveness in the education system, bringing together thirty -four members, called by the mayor at the beginning of each school year and at the end of each period of school interruption.



Braga Pedagogical Farm

The basic objective of the Braga Pedagogical Farm is to establish ties between generations, bringing people closer to the rural world (in particular preschool children, 1st cycle, children with special and senior educational needs), through pedagogies directed to the routines of Field/Nature, of the experience of rural traditions (defoliated, vindicate, magusto), the environmental preservation of agricultural and environmental ecosystems and the marking of environmental ephemeris. All this involvement is transmitted by teachings by conducting a panoply of pedagogical activities with transversal thematic areas to different audiences and patents in the pamphlets of "pedagogical activities" and respective activity plan.

Centro Qualifica

The Braga Qualifica Center, a collaborative consortium between educational and industrial entities, aims to enable adults to the labor market, promoting lifelong learning. With a personalized approach, identifies needs and directs candidates to appropriate educational programs. It offers free training at various levels of qualification, including school and professional, adapting to the individual needs of each participant for effective and successful integration into the labor market.

Network of Educating Cities - Charter from Educating Cities

Braga, as an active member of the Educating Cities Network, adopts a holistic approach to promote the educational and cultural development of its inhabitants. Inspired by the principles of the International Charter of Educating Cities, the city values its unique identity as it embraces cultural diversity and promotes intercultural dialogue. Urban planning prioritizes accessibility, social interaction and contact with nature, ensuring an inclusive quality of life for all its citizens. Braga undertakes to offer a welcoming and respectful environment, especially for those with special needs, promoting autonomy and equal opportunities for all.



Braga Living Science Center

The Braga Living Science Center (CCVB) promotes scientific and technological culture and dissemination, fostering the motivation to learn science through early contact with scientific knowledge, its agents and processes. In this center are performed experimental activities, in various areas of science, always guided by

specialized monitors. The activities are adapted and directed to various audiences, namely schools and families. These scientific actions are dynamized not only in the physical space of CCVB but also in schools/school grouping; other entities/partners; As well as abroad, as are the examples of environmental education actions in places of high ecological interest and astronomical observations of the night sky.

Educational modernization: Technological innovation and digitization on the SIGA platform and school card





Municipal Strategy for Adaptation to Climate Change

QualAr Plataform

The Qualar Platform represents a crucial tool in the Arsenal of the Municipality of Braga to deal with climate change. This platform provides valuable information about air quality, allowing a quick and effective response when ozone levels reach worrying levels. Through an automatic warning system, specially designed for citizens with breathing and heart problems, the municipality provides vital information to protect the health of the population. In addition, the partnership with the University of Minho allows a thorough analysis of the collected data, thus feeding informed decisions and the continuous improvement of climate change adaptation policies.

Efficiency in providing municipal services and transparent financial management are fundamental pillars for the sustainable development of Braga. Ensuring affordable, quality and effective administration strengthening citizens' trust and drives the region's socioeconomic growth.

MANAGEMENT APPROACH

The municipality of Braga has invested in the modernization of municipal services, betting on technological tools that allow greater efficiency in providing services to the citizen. The implementation of online service systems, such as the Municipal Municipal counter, has facilitated the population's access to public services, reducing waiting times and unnecessary travel. In addition, policies for training and training of municipal employees have been promoted, aiming to improve the quality of care and response to citizens' needs.

Financial management


The municipality of Braga adopted proactive policies to ensure transparent and responsible financial management. This included the establishment of strict budget planning procedures, such as budgeting, large plan options and multi -annual investment plan. In addition, detailed financial statements were available, such as the budget report and the accountability report, aiming to offer a comprehensive view of municipal finances. Corruption prevention was another priority, with the integration of specific formations on this theme for municipal employees. Acquisition operations followed clear procedures defined in the Code of Public Contracts, and a channel of complaints was established to promote transparency and ethics.



Management systems

The Municipality of Braga obtained certification for the Quality Management System (SGQ), implemented in the City Council. This

system was based on NP EN ISO 9001: 2015 and covered areas such as providing public service services, administrative management, territorial planning and issuance of opinions. A manual was designed to guide employees about SGQ policies and responsibilities, promoting continuous improvement and citizens' satisfaction.



Data protection

The municipality of Braga prioritized data protection, reviewing and continually updating data treatments from different organizational units. Formations were performed for employees, ensuring compliance with the general regulation on data protection. In addition, measures were adopted to ensure the veracity of the information disclosed to the press, reinforcing the image and reputation of the City Council.



Sustainable Procurement Practice

In line with the national strategy for ecological public procurement, the municipality of Braga promoted sustainability criteria in public hiring. Suppliers were evaluated not only based on quality and compliance with deadlines, but also on environmental and social criteria, such as the use of recycled materials, working conditions and suppliers' diversity. These practices aimed not only to ensure the efficiency of acquisitions, but also to promote sustainability and social responsibility values in the local community.


Citizen Response


Ensuring the ethical treatment of animals contributes to a fairer and more healthy community, strengthening social fabric and promoting harmony between humans and animals.

MANAGEMENT APPROACH

Braga has adopted an approach to implementing policies and comprehensive programs, including rigorous legislation on ethical animal treatment, public awareness campaigns to combat animal abandonment and partnerships with animal protection organizations. Infrastructure investments for accessible veterinary shelters and veterinary services have also been prioritized. In the municipality of Braga, the veterinary service plays a vital role in ensuring animal welfare. In addition to overseeing accommodation facilities, it contributes to infectious disease control actions. These actions aim not only to guarantee the well-being of animals, but also to promote harmony between humans and local fauna, thus contributing to sustainable and socially fair development in Braga.

POLICIES, COMMITMENTS AND OBJECTIVES

Regulation for Animal Welfare

The Municipality of Braga, in accordance with the principles of the Universal Declaration of Animal Rights proclaimed by UNESCO, established the regulation of animal welfare. This regulation reflects the city's commitment to respect for animal life and the promotion of appropriate conditions for its welfare, thus contributing to the sustainable development of the region. The animal welfare regulation has as its main objective to promote welfare, health and control of the animal population, especially animals. It defines the conditions of accommodation, possession, detention and animal circulation on the public road, as well as establishing measures to combat abandonment and promote responsible adoption. Additionally, it aims to ensure the execution of medical and sanitary prophylaxis measures by the Municipal Veterinary Service, as well as the proper functioning of the Braga Official Collection Center (CRO), integrated into the Municipal Veterinary Medical Office.

This regulation covers not only the animals of company, but also other species, such as wild animals and animals for livestock purposes, ensuring a holistic approach to animal protection. Its implementation is conducted in accordance with current legislation, ensuring a legally solid and coherent action.

The goals of the regulation follow:

_ Identification and control of the animal population: The regulation establishes guidelines for the identification and control of the animal population, aiming to avoid uncontrolled growth and the spread of diseases.

_ Accommodation and Possession Conditions: Defines minimum animal welfare standards to ensure that animals have adequate accommodation conditions and care by their holders.

Fight against abandonment and promotion of adoption: implements measures to prevent animal abandonment and promote responsible adoption, encouraging the community to take responsibility for the animals it welcomes.

_ Medical and Sanitary Prophylaxis: Ensures the execution of disease prevention and treatment measures, ensuring the health and welfare of animals covered by the regulation.

_ Operation of the Official Collection Center: Establishes guidelines for the proper operation of the Braga Official Collection Center, ensuring the decent and adequate treatment of the collected animals, as well as their eventual reintegration in society.

The implementation of this regulation demonstrates the commitment of the Municipality of Braga to sustainable development, by promoting harmony between humans and animals and ensuring the preservation of local biodiversity. In addition, it contributes to a fairer and more compassionate society, where respect for animal life is a Targadamentation.

RESOURCES

BRAGA OFFICIAL COLLECTION CENTER (CRO)

CRO was a fundamental initiative for the municipality in its mission of promoting animal welfare and sustainable development. With recently renewed facilities, CRO offers a safe and comfortable environment for abandoned, wandering or delivered animals to the authorities' care. Its 27 cat boxes and 32 dog boxes, divided into different wings, provided adequate space for accommodation and recovery. In addition, the 2 quarantine boxes guaranteed the necessary separation in specific cases. CRO also has 24 outer parks for dogs and 1 for cats, promoting the exercise and socialization of animals, thus contributing to their physical and emotional well-being.



Municipal Veterinary Medical Office

The Municipal Veterinary Medical Office plays a crucial role in the support and promotion of animal health in Braga, in defense of health and animal welfare, public health as well as the promotion of sterilization programs and control of the animal population. It is committed to public health, animal population control and emergency assistance. Focusing on the prevention and responsible care, it aims to ensure the quality of life of local animals and promote a harmonious coexistence between humans and animals.

Animal component of Braga's Pedagogical Farm

In the visit to Braga's Farm Pedagogical, children have the unique opportunity to interact directly with the farm animals, providing them with an enriching and educational experience. This close contact allows them to better understand animal life cycles as well as the importance of their welfare and food. Most animals present in the pedagogical fifth are native races, thus contributing to the preservation and dissemination of local genetic heritage. From small animals such as birds, rabbits and gallinats, to medium and large animals, such as ducks, geese, sheep, goats, pigs and cattle, animal diversity provides a complete and varied experience to visitors.





INITIATIVES

Veterian Voucher

The municipality of Braga, in collaboration with the Order of Doctors, actively participated in the National Program for Veterinary Health Support for Company at risk, offering the sterilization veterinarian.



Support for animal protection associations

The municipality of Braga demonstrated its commitment to animal protection by providing logistical support to CED -filed associations



Actions against abandonment and abuse of animals

The municipality of Braga led several actions against abandonment and animal abuse, in partnership with local entities such as Nortdog - Canine Academy of Braga, the Bragatos Association and the Adaúfe Veterinary Clinic. The initiative of the reception of pets belonging to individuals infected with Covid-19 was especially highlighted, aiming to avoid abandonment and ensure the welfare of animals during periods of crisis.



Animal provider

The municipal provider of the animal was established, with the mission of receiving, analyzing and resolving complaints related to animal welfare. This initiative, lasting four years, reinforced the commitment of the municipality of Braga to the protection and promotion of animal rights in the community.



Animal food bank

The Animal Food Bank was a pioneering initiative promoted by the Municipality of Braga, aiming to provide essential foods and resumes for vulnerable animals. This project contributed significantly to ensure adequate feeding of animals welcomed in different institutions and to support needy families in the feeding of their pets.

The "Animal Socorro" project was a rapid and effective response action in emergency situations involving animals, such as endangered animal rescues, injured animal assistance or in impending risk situations. 


Educational Project "Friend of the Animal School"

Youth Center of Braga


Braga recognized as a sustainable destination at Green Destinations Awards



In 2023, there was a significant increase, reaching 64.4%. Braga has implemented several initiatives to combat poverty and promote social inclusion. The social development plan, the local housing strategy and housing programs directed to vulnerable families are highlighted. In addition, social support has been offered to ensure equitable access to economic resources and basic services. Although there is advances, the weight of housing is still a factor that limits the full realization of this SDG in Braga. However, employment insertion strategies have been successfully implemented, aiming to increase employability and reduce the economic vulnerability of the population. With a continuous commitment to inclusive social policies and support programs, Braga is on the right track to reach the targets established by SDG 1 and ensure that all its inhabitants have equal opportunities and access to the necessary resumes for a dignified life.

Review



Braga's performance in SDG 2 has shown a positive evolution over the last few years. In 2019, the realization rate was 45.8%, and since then there has been constant growth, reaching 57.4% in 2023. Braga has adopted several initiatives to promote food safety and end malnutrition. The Nutrition and School follow-up program is highlighted, which ensures the quality of meals served in schools, ensuring that all children have access to suitable foods for their development. In addition, the pedagogical fifth is an emblematic example of agricultural practices and sustainable rural development in Braga. This initiative not only promotes the production of healthy foods, but also educates the community about resilient and sustainable agricultural practices. Productive and sustainable agricultural practices have contributed positively to the advancement of SDG 2 in Braga, especially to the production of biological foods, which has a prominent gain in the region. However, there is still a need for greater data availability for an effective SDG location.





Braga has recorded remarkable performance at SDG 3. Over the past few years, the city has shown continuous improvement in this goal. In 2019, the realization index was 86.8%, and since then has maintained a positive trajectory, reaching 87.8% in 2023. One of the fundamental initiatives in Braga was the 2021-2026 Municipal Health Plan, which establishes guidelines and targets to improve the health of the population. In addition, the city has offered crucial support in combating Covid-19 pandemic, implementing prevention measures and promoting vaccination. Braga has also invested significantly in infrastructure and municipal equipment in health and sports, thus strengthening the resumes available for the well-being of the community. The sports letter is an initiative that promotes the practice of physical activities, contributing to the active promotion of health. Despite significant progress, Braga still faces challenges related to substance abuse, including drugs and alcohol, which represent negative points in the promotion of the population's health and well-being. In 2019, the index was 92.6%, and although there have been some variations in the following years, as in 2022 with 89.7%, Braga continues to maintain A significantly above national average performance reaching 91.1% in 2023. One of the remarkable achievements is the guarantee of universal and equitable drinking water access to all at affordable prices over the last years. Good practices adopted by AGERA in water management, especially with regard to reducing real water losses, have contributed to improving the quality and availability of this vital resource, besides, urban cycle policies and water management implemented in Braga They have played a crucial role in this success, allowing efficient management of water resumes in the city. Despite advances, it is important to recognize that the amount of water distributed per inhabitant has increased, which has slightly impacted the achievement of the goal. However, Braga continues to maintain very high achievement levels in SDG 6, indicating a continuous commitment to promoting universal access to safe drinking water and proper sanitation for all its citizens.



Braga has achieved a very high performance on SDG 7, which aims to ensure universal access to renewable and accessible energy for all. In recent years, the city has recorded a significant improvement in this respect. In 2019, the realization index was 79.9%, and since then has maintained an upward trajectory, reaching 91.1% in 2023. One of the main initiatives implemented in Braga is the sustainable energy and climate action plan, which It establishes guidelines and targets to promote the use of renewable energy and reduce dependence on fossil fuels. In addition, the city has developed innovative projects in the area of sustainable energies, looking for alternatives to expand sustainable energy infrastructure. The Batteries 2030 project is an example of this effort. On the other hand, energy efficiency programs have played a key role in reducing energy consumption and promoting sustainable practices in public lighting. The city has developed a local housing strategy, implementing housing support programs to ensure proper and safe access to housing. In addition, the sustainable urban mobility plan aims to reduce greenhouse gas emissions, although challenges persist, especially in the transportation sector. Several significant investments were made in urban parks, with special prominence for the Sete Source Park. The appreciation of cultural heritage through the Braga 2030 strategy and the candidacy for the European capital of culture reflects the city's commitment to integral and sustainable development. Despite these and other initiatives, Braga faces challenges to reach different SDG targets, such as high housing costs and mobility greenhouse gas emissions. On the other hand, Covid-19 pandemic significantly affected investment in the cultural sector, due to the stopping of activities. In the context of waste management, Braga also faces some challenges, with spatial attention to the high production of waste per inhabitant although there has been a significant increase in recycling and reuse of urban waste, fulfilling even established targets for 2030. Thus, Braga has Demonstrated a growing commitment to SDG 11, implementing comprehensive strategies to build a more sustainable and inclusive city, although there is still room for improvements in many aspects.



Braga has witnessed a remarkable evolution in SDG 12, which aims to reduce global food waste, achieve environmentally healthy chemical management and substantially decrease waste generation. In the last three years, the city has shown significant progress in this regard, with a constant increase in the realization index. By 2020, the index was 24.2%, and since then there has been continuous improvement, reaching 53.3% in 2023. This evolution reflects Braga's commitment and investment with the promotion of environmental sustainability and the efficient management of resumes. Braga has implemented several initiatives to address these issues. The urban waste collection system is constantly evolving, aiming at a more effective management of the waste generated by the population. This distinction reflects the city's significant efforts to reduce greenhouse gas emissions and promote sustainable practices. Despite the challenges still faced, the Braga community has been strongly involved in decarbonization of the city and adapting to climate change, as evidenced by the growing number of schools classified with Eco-Schools and parishes classified with Eco-Frequuesias. With a continuous commitment and the active participation of the community, Braga is well positioned to face climate challenges and build a more sustainable and resilient future for all.



Braga, despite not having a sea border, plays an important role in the conservation and sustainable use of marine resumes, as advocated by SDG 14. However, the location of both Targets and indicators for SDG 14 can be discussed and difficult to definition. Although these challenges, policies and actions carried out on water lines have a significant impact on issues related to marine and coastal ecosystems. The conservation of water lines and sustainable management of water resources contribute to the reduction of pollution and the preservation of aquatic ecosystems. In recent years, Braga has shown a gradual increase in the SDG 14 achievement index, from 33.2% in 2019 to 41.0% in 2023. In indicators related to quality with water lines within the area of its responsibility There is a good progression of the indicators towards TARG. in which its realization is estimated in 2030. This evolution reflects the city's efforts to preserve its water lines, through urban cycle policies and water management, as well as the requalification of river beaches, many of which sport Blue flag, symbol of environmental quality.

Braga has played an exemplary role in promoting conservation and sustainable use of terrestrial ecosystems, as established in SDG 15. In recent years, the city has shown a remarkable progression in the implementation index of this objective, from 90.9% in 2019 to 94.0% in 2023. The afforestation plan and the municipal forest defense plan against fire are clear examples of the city's commitment to the protection of forests and other natural habitats. In addition, Braga has invested significantly in the conservation of urban green spaces, such as Monte Picoto Urban Park, Ponte Park and Camelias Urban Park. Innovative initiatives such as microforests, braga and ecological restoration of natural/degraded habitats have significantly contributed to the preservation of local biodiversity and the recovery of degraded ecosystems. Thanks to these efforts, Braga has reached some SDG 15 targets ahead of expected, highlighting considerably compared to the national average. The city's commitment to nature conservation and sustainable management of natural resumes continues to strengthen its position as a leader in promoting biodiversity and fighting desertification and deforestation. Thus, with such positive progression and impactful projects ongoing, it is estimated that Braga fully reaches SDG 15 to 2030, contributing to a more sustainable and balanced future for all.



Braga has been striving to promote a fair, peaceful and inclusive society, as established in SDG 16. In recent years, the city has maintained consistent performance, although with some fluctuations, in the implementation index of this objective, recording 79.4% in 2023, after reaching a peak of 81.6% in 2019. To achieve these results, Braga implemented several policies and initiatives aimed at promoting safety, risk prevention and promotion of transparency and social integration. The Municipal Police Service plays a key role in maintaining public order and safety in the city. In addition, the management risk prevention plan, corruption and related infractions and transparency policies have contributed to strengthen the rule of law and effective governance. However, despite progress in some areas, Covid-19 pandemic may have negatively impacted some key indicators. The reversal of the positive trajectory during the pandemic years, in some indicators, generates doubts about the need to increase measures to face security threats and promote equal access to justice to all citizens. Registration and reading of data from the coming years will be significant to understand the impact of this SDG. Thus, despite the challenges, SDG 16 has a high progression compared to the average of the rest. Braga remains thus committed to promoting fair and inclusive societies, constantly seeking new strategies and approaches to facing emerging problems and further strengthening social cohesion and peace in the community.



Over the years, the city has shown constant progress in SDG 17, reaching a 56.3% achievement in 2023, compared to the 43.8% registered in 2019 and 2020. To strengthen this global partnership, Braga He adopted a proactive approach, seeking to establish significant collaborations in various parts of the world. The city's internationalization policy has been fundamental in this regard, resulting in partnerships on different continents. In addition, an efficient financial policy has contributed to reducing municipal debt, releasing resumes for investments in sustainable development. Braga's presence in large SDG -related forums and events, in cooperation with the United Nations, has been remarkable. This demonstrates the city's commitment to contribute to global efforts for sustainable development. However, it is important to highlight the challenges faced in locating and obtaining data aligned with the indicators needed to monitor SDG 17 progress at the municipal level. Nevertheless, Braga's cooperation for sustainable development in other regions has been very significant, with high impact projects.
